DETAILS OF MAIN EXAMINATION

A. Compulsory Paper

- 1. General Knowledge (including Knowledge of Current Events): This paper will also include questions of Indian History, Culture and Geography of a nature which candidates should be able to answer without special study.
- 2. Elementary General Science: A paper of questions to test such matters of everyday observation and experience in their scientific aspects as may be expected of an educated person who has not made a special study of any scientific subject.

- 4. General English: This paper tests candidates' understanding of English language and his/her ability to write in English. Questions are asked from an unseen passage for summary or precis writing, letter writing and others.

 - (i) Indian Evidence Act, 1872
 - (ii) Civil Procedure Code, 1908
 - (iii) Arbitration and Conciliation Act, 1996
 - (iv) Criminal Procedure Code, 1973
 - (v) Provincial Small Causes Courts Act, 1887

B. Optional Papers (3 Papers to be chosen) $(150 \times 3 \text{ Marks})$

- 1. Constitutional Law of India and Administrative Law: This paper includes
 - a) The Government of India Act, 1935.
 - b) Indian Independence Act, 1947.
 - c) The Constitution of India.

Administrative Law will cover following topics – Delegated legislation, Control of delegated legislation - Judicial and Legislative, Fair hearing-rules of natural justice, rule against bias, audi alteram partem, Tribunals and Quasi judicial authorities-judicial control over them, Regulatory authorities, Judicial review of administrative action, Writ jurisdiction and statutory judicial remediesscope, extent and distinction, public interest litigation, Tortious liability of state and

compensation, Promissory estoppel, legitimate expectation and doctrine of proportionality, Government contracts, Ombudsman.

- 2. <u>Hindu Law:</u> Sources of Hindu Law, Different schools of Hindu law, Marriage, Sonship, Adoption, Joint family and joint property, Impartible estates, Debts, Alienation, Partition, Succession, Stridhan, Widows's estate, Wills, Gifts, Religious and charitable endowments.
 - <u>Mohammadan Law:</u> Sources of Muslim law, Origin and development of different schools, Extent of its application in India, The Shariat Act, 1937, Effect of conversion to Islamic Religion, Succession and Administration, Wills, Hiba, Hiba-bil-Ewaz, Waqf, Maintenance, Parentage legitimacy and acknowledgement, Guardianship.
- 3. <u>Law of Transfer of Property and Principles of Equity:</u> This paper includes the Transfer of Property Act, 1882, Principles of Equity, Law of Trust and Specific Relief Act, 1963. History of Court of Equity, Maxims, Origin of use, Development of trust from custom/usage. Definition of trust, Formalities in constituting trust, Classification of trust, Express, Employed, Resulting, Constructive, Private, Public and benami transactions. Principles of Advancement, Comparison, Duties and rights of trustee, Determination of Trust, Remedies for breach of trust.
- 4. <u>Law of Contracts and Torts:</u> This paper includes Indian Contract Act, 1872 & Law of Torts Nature of Torts, General Principles of Liabilities, Tortfeasor, Remedies, Nuisance, Injuries to persons, Assault, Battery, False imprisonment, Injuries to Domestic and Contractual Relations, Wrongful dismissal, Defamation, Negligence, The Rule in Rylands vs. Fletcher, Deceit, Conspiracy, Malicious Prosecution.
- 5. <u>Commercial Law:</u> The main principles of law relating to Sale of Goods, Negotiable Instruments, Company Law and Partnership.
