INTERVIEW

No candidates appearing for the Sikkim Superior Judicial Service Examination shall be qualified to appear for viva-voce unless a candidate's secure minimum 40% marks in aggregate and each paper respectively

- (i) Only such number of candidates shall be called for viva voce as shall obtain the highest marks in aggregate of both the papers in the written examination. up to the extent of five times of the number of posts as specified, in the advertisement inviting applications.
- (ii) Selection of candidates shall be made on the basis of the aggregate marks obtain in the examination and viva voce.
